When you visit our WordPress website or use our Wi-Fi:

- IP address
- Device and browser information
- Cookies and tracking technologies
- Usage data (pages visited, time on site, clicks)
- Location data (approximate)

#### **D.** Information from Third Parties

We may receive information from:

- Payment processors (transaction confirmations)
- WordPress plugins
- Analytics providers (e.g., Google Analytics)
- Social media platforms (if you interact with our content)

### 2. How We Use Your Information

We use your information to:

- Process transactions and fulfill orders
- Provide in-store and online customer service
- Communicate order confirmations and receipts
- Manage website accounts
- Improve website functionality and security
- Send optional marketing emails or promotions (you may opt out anytime)
- Detect fraud or security issues
- Comply with legal and tax obligations

We do **not** use your information for automated decision-making that produces legal or similar significant effects.

### 3. How We Share Your Information

We only share information as necessary to operate our business. We **do not sell** personal information.

We may share information with the following:

• Payment processors (e.g., Square, Venmo, Apple Pay, PayPal)

- Website hosting providers
- WordPress plugins and service providers (order management, security tools)
- Email marketing services (if you opt into newsletters)
- Shipping carriers (if you purchase physical items online)
- Professional service providers (IT, legal, accounting)
- Law enforcement or government authorities if required by law

All service providers are required to safeguard your information.

# 4. Cookies and Tracking Technologies

We use cookies and similar technologies to:

- Keep your shopping cart active
- Enable secure transactions
- Improve website performance
- Analyze traffic and usage patterns

You can disable cookies through your browser settings, but doing so may affect website functionality.

### 5. Data Retention

We retain personal information only as long as necessary to:

- Process transactions
- Meet tax, bookkeeping, or legal requirements
- Maintain active customer accounts
- Support fraud prevention

Online accounts may be deleted upon request.

## 6. How We Protect Your Information

We implement reasonable security measures, including:

- Encryption of data in transit
- Secure caching and storage on WordPress

### E. Right to No Discrimination

We will never discriminate against you for exercising your privacy rights.
